Dear Chief Whitten:

I am writing to inquire information regarding your letter of July 21, 2011. In your letter you mention the U.S. Nuclear Regulatory Commission (NRC) received a letter dated December 16, 2010, from Pa`ina Hawaii, LLC (Pa`ina), requesting an amendment to the NRC license 53-29296-01 to add a second location of use for an irradiator at 92-1780V Kunia Rd. Kunia, HI.

NRC staff informed Pa`ina Hawaii, LLC that the amendment request was being voided without prejudice due to insufficient information. Pa`ina Hawaii LLC reinstates its request on March 8, 2011, to amend NRC license 53-29296-01 to add a second location of use by providing additional information to support the request for the second location of use.

I would appreciate it if you will be so kind to send me copies of Mr. Namu`o letter of December 16, 2010, requesting for a second location of use for an irradiator and March 8, 2011, letter modifying the first one with additional information requested by your department.

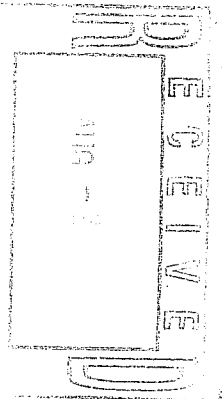


