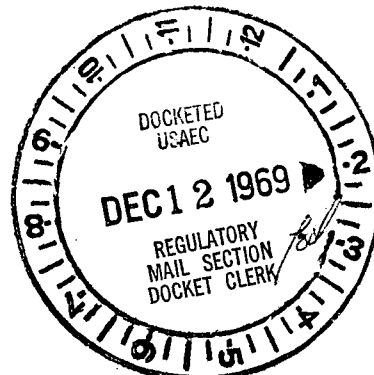
Dear Dr. Morris:

With this letter we are transmitting one hundred (100) copies of Amendment No. 12 to the license application for the Duane Arnold Energy Center.

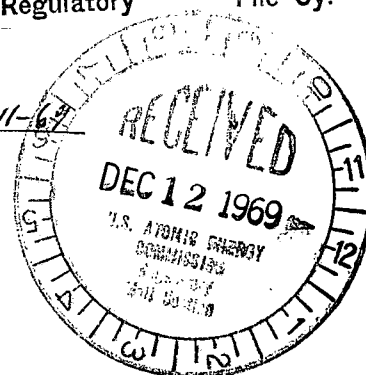
