SUBJECT: TERMINATION OF NRC RADIOACTIVE MATERIALS LICENSE

By letter and NRC Form 314 dated July 28, 2011, you informed the U.S. Nuclear Regulatory Commission (NRC) that you wished to terminate your NRC radioactive materials license number 42-29370-01. The license termination request stated that all radioactive material had been transferred to Schlumberger Technology Corporation NRC license number 42-00090-03. Based on the documentation submitted and a review of E&P Wireline Services and Schlumberger Technology Services historical files, the staff concluded that all licensable radioactive material has been transferred to Schlumberger Technology Corporation. No further remediation or action with respect to NRC regulated material is required since license number 42-29370-01 only had temporary job site authorization.

Please find enclosed Amendment Number 04 to License Number 42-29370-01, authorizing your license termination. An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14)(xi).
