NRC staff contacted the licensee to clarify the following information provided in an amendment request letter dated July 5, 2011:

1. Licensee name on license is different from that provided on letterhead in the amendment request letter. During a review of the license docket files, it was noted in a recent renewal cover letter that the licensee letterhead referred to their name as "Braxton County Memorial Hospital" and not "Braxton County Hospital" as was indicated on the license application. Mr. Vincent clarified that there was an inadvertent error and the licensee name should be "Braxton County Memorial Hospital", and that they had never undergone a name change. He explained that they were originally an independent hospital, and were later acquired by the Charleston Area Medical Center (CAMC) Health System. They were later able to buy themselves back from CAMC to become an independent agency once again in July 2007. The corporation and the licensee name stayed intact and always remained the same, and when CAMC was in control, they kept the same staff for services. Their initial application submitted in 2006 was part of them becoming an independent agency once again. In the buy back process and in corresponding with NRC, they were informed to go ahead with a new license in anticipation the process being completed in about one year. Mr. Vincent agreed to provide a something in writing that indicates that the licensee name has always stayed the same by COB on August 11, 2011.
2. Dr. King's name suffix as listed on the license was spelled erroneously as Russell F. King, III, M.D. Mr. Vincent confirmed that the correct spelling of his name is "Russell F. King, II, M.D."
3. Possession and/or use of NARM material and locations of use NARM. The licensee confirmed that all locations of use of all material including NARM are adequately described in their license.
