SRP 02.04.02: SUPPLEMENTAL RESPONSE TO RAI LETTER 63

On April 7, 2011, the NRC requested additional information to support the review of certain portions of the North Anna Unit 3 Combined License Application (COLA). The responses to the Request for Additional Information (RAI 5574) questions were provided in letter NA3-11-018R dated May 3, 2011.

The response to Question 02.04.02-9 included a figure which identified the North Anna Unit 3 site locations with supercritical velocities and hydraulic jumps as computed by the HEC-RAS model analysis described in the Unit 3 FSAR Section 2.4.2.3. (The areas of supercritical velocities and hydraulic jumps are important with regard to site drainage flow during periods of intense precipitation.) The figure provided in the response focused on the site area surrounding the main power block structures. During subsequent discussions with the NRC staff, it was noted that an additional supercritical velocity area and a hydraulic jump on the site and considered in the HEC-RAS model was not shown on the figure due to scale. Therefore, the response to Question 02.04.02-9 is being re-submitted with the figure's scale adjusted to show all site areas with supercritical velocities and hydraulic jumps. Please note that other than adjusting the scale of the figure, Dominion's response is unchanged.

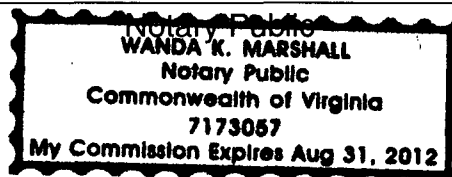
