SUBJECT: SUMMARY OF AUGUST 18, 2011, PUBLIC CONFERENCE CALL
WITH DETROIT EDISON REGARDING COMBINED LICENSE
OPEN ITEMS

On August 18, 2011, a public conference call was held between the U.S. Nuclear Regulatory Commission (NRC), and representatives of Detroit Edison (DTE). The purpose of the meeting was to provide DTE an opportunity to present information related to open items in the Fermi 3 Safety Evaluation Report (SER).
