


The purpose of this modification is to (1) extend the PBX Maintenance for one (1) month in duration, thereby extending the maintenance period from August 15, 2011 to September 15, 2011, (2) provide funding in the amount of \$3,292.02, thereby increasing the obligation amount from \$655,634.00 to \$658,926.02 and (3) revise the total estimated contract value.

Accordingly the following changes are as follows:
