ORDER

The Blue Ridge Environmental Defense League recently filed motions to reopen the record and/or admit a new contention before the Atomic Safety and Licensing Boards that earlier conducted the contested portion of the captioned proceedings.¹ Both contested proceedings have been terminated, however, and jurisdiction over the filings lies with the Commission.
