Page 2, paragraph 2 of Task Order 26 (first sentence) is hereby deleted and replaced with the following:

"Task Order No. 26 shall be in effect from 07/28/10 through 03/31/2013 with a cost ceiling of \$151,789.68.

Page 2, paragraph 3 of Task Order 26 is hereby deleted in it's entirety and replaced with the following paragraph:

"The amount obligated by the Government in respect to this task order is \$128,000.00 of which \$121,906.00 represents the reimbursable cost, and the amount of \$6,094.00 represents the fixed fee."
