For your information:

1. The July 27, 2011 audit report is in typing and should be ready for issuance today. The discussion does not appear to contain any proprietary information and I don't plan to send you a draft for proprietary review. If you feel there is a need to, please let me know by COB today.
2. The May 24, 2011 audit report is being held up because there is no contractor funding until later this week, I hope.
3. RAI 03.09.01-1 asked why the FSAR markup in 03.09.02-21 response reads "**ACSTIC**" instead of "**ACSTIC2**". This should be an easy one. But I am also talking to Samir and Manas if there is any need to update Appendix 3D of the STP FSAR to show the proper version of SHAKE, SAP, and SASSI (and perhaps others). The current DCD FSAR does not show the specific code version.
4. Back to 03.09.02-21 response: the current FSAR markup in Section 4.1, Appendix 3D says ACSTIC is described in 4.1.4.1. Shouldn't the discussion also include 3.9.2.x? Just a thought but we may need to be consistent while we still have a chance to avoid future question.
5. In Chapter 3.9.2, since the predictive analysis takes on a different approach than before (ACM methodology no longer used), any of the previously provided FSAR, including Chapter 14.2, needs to be revised? And when?
