Upon consideration of the August 22, 2011 motion of (1) applicant Tennessee Valley Authority (TVA) to exceed the page limit for its response to the August 11, 2011 motion of Joint Intervenors* for the admission of a new contention regarding the safety and environmental implications of the July 12, 2011 NRC task force report on the Fukushima I accident; and (2) the NRC staff to exceed the page limit for its response to Joint Intervenors August 11, 2011 motion to admit a new contention regarding the Fukushima I task force report and for an extension of time within which to file the staff's response to Joint Intervenors motion to admit this Fukushima I-related new contention, and there being no opposition thereto, it is

ORDERED, that the TVA August 22, 2011 motion to exceed the page limit for its response to the Joint Intervenors August 11, 2011 motion to admit a new contention is granted; and it is

FURTHER ORDERED, that in accord with the Licensing Board's June 8, 2008 initial prehearing order, see Licensing Board Memorandum and Order (Initial Prehearing Order) (June 18, 2008) at 6 & n.3 (unpublished), any reply by Joint Intervenors to the TVA and/or staff responses to Joint Intervenors motion to admit a new contention regarding the Fukushima I accident shall be filed within seven days after the staff's response is submitted.
