SUMMARY

This refers to Letter dated April 20, 2011 (with attachments) and the phone conversation between James Mosier and Mike Herr on July 25, 2011.

During our review of your letter dated April 20, 2011 we noted that you did not include the documentation of training for James Mosier. Please refer to Section 8.7.1 of NUREG 1556, Vol. 1, date October 1998, "Consolidated Guidance about Materials Licenses: Program-Specific Guidance about Fixed Gauge Licenses" for what training is required for a Radiation Safety Officer (RSO) and provide the appropriate training documentation for Mr. Mosier.

As we discussed on our phone conversation, as part of a NRC Policy change, a written statement must be provided that the proposed RSO must confirm that s/he accepts the position as RSO and that s/he understands the duties and responsibilities associated with the RSO position. Please provide a written, signed, and dated statement that Ms. Mosier accepts the position as RSO and that she understands the duties and responsibilities associated with the RSO position.


