Dear Dr. Madrazo:

Enclosed is Amendment No. 15 to your NRC Material License No. 21-32102-01 in accordance with your letter dated April 18, 2011. Please note that the major changes made to your license are printed in **bold** font.

In your letter, you indicated that you wished to remove four Areas of Use, identified previously as Schoenherr Area #1, in your NRC license application dated June 6, 2008. The NRC staff has reviewed your final status surveys for Schoenherr Area #1, located at 37771 Schoenherr, Sterling Heights, Michigan. Based on its review, the staff has concluded that all radioactive material has been removed from Schoenherr Area #1 and residual radioactive material attributable to licensed activities, in that area, does not exceed current NRC criteria.

Based on these conclusions, no further remediation or actions with respect to NRC regulated material is required, for Schoenherr Area #1. The four Areas of Use, identified in your letter dated April 18, 2011, are suitable for unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system. Pursuant to NRC's RIS 2005-31 and in accordance with 10 Code of Federal Regulations 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.
