SUBJECT: Report for the November 9, 1988, Exercise of
the Offsite Radiological Emergency Response
Plans Site-specific to the Duane Arnold
Energy Center

Attached is a copy of the report for the November 9, 1988, full-participation exercise of the offsite radiological emergency response plans for the Duane Arnold Energy Center. The State of Iowa and the Counties of Linn and Benton participated fully in the exercise. Johnson County participation was limited to the activation of the reception/monitoring center at the University of Iowa. The report was prepared January 9, 1989, by Region VII of the Federal Emergency Management Agency (FEMA).

The four deficiencies identified during the November 9, 1988, exercise were corrected during the remedial exercise conducted on December 1, 1988. The evaluation of the remedial exercise has been included in the attached report. The Area Requiring Corrective Action (ARCA) which had been identified during the November 18, 1986, exercise concerning inadequate instrument calibration was corrected during this exercise. Two of the thirteen ARCAs identified during the November 9, 1988, exercise are to be corrected by the State's submission of appropriate plan changes. The two ARCA's concerning dosimetry for ambulance crews are scheduled for correction during the next annual Medical Drill. The remaining nine ARCAs are scheduled for redemonstration during the next full-participation exercise, currently scheduled for 1990.
