SUBJECT: NOTICE OF VIOLATION - NRC Inspection Report Nos. 03037029/2011001 and 03037029/2011002

Dear Mr. Baker:

This refers to the safety and security inspection conducted between May 10 and 31, 2011 at the Baker Inspection Group facilities at ICL-IP Americas (formerly Supresta, US LLC), Gallipolis Ferry, West Virginia and at Bayer Polymers, New Martinsville, West Virginia. The purpose of the inspection was to examine licensed activities as they relate to radiation safety, security, and compliance with the Commission's regulations and the conditions of your NRC license. During the inspection, at least one apparent violation of NRC security requirements was identified. The actual number and nature of security-related violations are considered to be sensitive information, and are therefore not included in this letter, but are provided in a non-public enclosure. The apparent violation(s), which were discussed with you and Joseph Wolfe, Radiation Safety Officer, of your organization at the conclusion of the inspection during an exit meeting teleconference on May 31, 2011, were described in the non-public subject inspection report issued on June 30, 2011.

The June 30, 2011 letter transmitting the inspection report indicated that since your facility had not been the subject of escalated enforcement actions within the last two years or two inspections, a civil penalty may not be warranted in accordance with Section 2.3.4 of the NRC Enforcement Policy, but that the final NRC decision would be based on Baker Inspection Group providing specific information to the NRC. The requested information included the following: (1) confirmation that the corrective actions previously described to the NRC staff have been or are being taken; (2) a description of the root cause of the apparent violation(s) and a description of overall facility performance, including the time period of the deficiencies; and, (3) the long-term corrective actions your facility committed to take in order to prevent recurrence of the issues.

Enclosures 1 and 2 transmitted herewith contain Sensitive Unclassified Non-Safeguards Information. When separated from Enclosures 1 and 2, this transmittal document is decontrolled.
