Don/Ryan,

Luminant, in its RAI responses, will sometimes include changes to the USAPWR DCD. While developing our safety evaluations, we became concerned about the following: 1) these DCD changes are not being tracked as part of the USAPWR DCD tracking report, and

2) MHI may not have agreed to these DCD changes. As such, whenever, Luminant includes proposed USAPWR DCD changes as part of its RAI responses, I would like to see a statement in Luminant's cover letter that MHI has agreed to the DCD changes. Furthermore, I would like these DCD changes to be included as part of MHI's DCD Tracking Report. That would assist us in tracking these changes as part of the DCD review.
