The new location is currently used as a nuclear cardiology practice owned and operated by "Cardiology Physicians, P.C." under NRC radioactive materials license number 06-30769-01.

2. Kathleen Harper, D.O. as owner of "Cardiology Physicians, P.C." , medical director and RSO requests the termination of the practice NRC license number 06-30769-01. Dr. Harper is co-signer of this amendment letter.

3. St. Vincent's Medical Center accepts the new site owned by Cardiology Physicians, P.C. as is, including all imaging and non-imaging equipment, radioactive materials authorized under the office license, office documents, records, ALARA reports, the office authorized users and the office policies and procedures. We will maintain the possession limits set in the hospital NRC license.

4. The new site will be administratively under the hospital Chief Executive Officer, Susan Davis, R.N., Ed.D., and will be operated by the hospital department of cardiology. The new site radiation safety program will be under the hospital Radiation Safety Officer, Adel Mustafa, Ph.D. The new site activities and radiation safety program will be routinely reviewed by the hospital radiation safety committee.
