**THE DEPARTMENT OF ENERGY'S NOTICE OF SUBMISSION OF  
LSN DOCUMENT COLLECTION**

On April 11, 2011, the Construction Authorization Board issued an Order requiring that each party in this proceeding submit its Licensing Support Network (LSN) document collection, along with associated bibliographic files, to the Office of the Secretary of the Commission (Secretary) on optical storage media for inclusion into the Docket. In accordance with that Order, the United States Department of Energy (DOE) provides notice that it has submitted its LSN document collection. DOE has provided to the Secretary the PDF images of all the documentary material on its LSN that were available in full-text and image format, along with their associated bibliographic header information, and only the bibliographic header information for those documents that were on DOE's LSN in header-only format. Given the size of DOE's LSN document collection, and in accordance with the Order, DOE submitted its LSN document collection in four installments to the Office of the Secretary of the Commission. On August 31, 2011, DOE submitted its final installment to the Secretary. DOE also certifies that it has

provided a true and accurate representation of the materials available on the LSN at the time of submission to the Secretary.
