Mr. Comar,

A concern at least as big as population changes within the 10 mile EPZ, is that the estimated shadow evacuation population estimates contain invalid assumptions (boundaries are discrete, arbitrarily, and exclude many likely shadow evacuees).

Is this problem to be addressed as well?

Manny, does this mean that all existing and pending reactor operators will have to re-evaluate their evacuation estimate times and plans now based on the 2010 census? Will there be such a directive on this?

We see this statement in the ruling:

*In addition, the new rule requires nuclear power plants to update their evacuation time estimates after every U.S. Census or when changes in population would increase the estimate by either 25 percent or 30 minutes, whichever is less.*
