SUBJECT: MEETING BETWEEN THE U.S. NUCLEAR REGULATORY
COMMISSION STAFF AND DETROIT EDISON COMPANY TO
DISCUSS RESPONSES TO REQUEST FOR ADDITIONAL
INFORMATION FOR THE FERMI 3 PROJECT
ENVIRONMENTAL REVIEW

On August 29, 2011, the U.S. Nuclear Regulatory Commission (NRC) staff held a teleconference meeting with the Detroit Edison Company (Detroit Edison) to discuss request for information responses received from Detroit Edison and issues raised during the environmental review of the Fermi 3 combined construction and operating license (COL) application leading to preparation of the draft environmental impact statement (EIS). Enclosure 1 lists the meeting attendees.

A public meeting notice was issued on July 27, 2011, and was posted on the NRC's external (public) webpage (NRC Agencywide Documents Access and Management System Accession No. ML112010141). The notice included a brief meeting agenda.

A summary of discussions included the status of: (1) cultural resource activities, (2) air quality analysis findings, (3) Detroit Edison's Joint Permit Application to the Michigan Department of Environmental Quality (MDEQ), and (4) the Fermi 3 COL draft EIS is presented below. Action items are identified below as **[ACTION ITEM]**.

Cultural Resources

- NRC has developed a Memorandum of Agreement (MOA) regarding the demolition of Fermi 1. The draft MOA was submitted to the Michigan State Historic Preservation Office (SHPO) on August 26, 2011.
- On August 22, 2011, NRC express-mailed a concurrence request letter to the Michigan SHPO regarding the *Application for Section 106 Review* dated December 16, 2010.

Air Quality

- Table 4.8-1 of the environmental report describes the construction/preconstruction contribution split as 70/30 and provides a brief justification of the basis for that split. NRC is preparing a conformity applicability analysis for construction activities and requested additional supporting information used by Detroit Edison to calculate the 70/30 split.
- Detroit Edison provided a written response to this request on July 7, 2011. NRC is reviewing this response and will identify additional questions if needed **[ACTION ITEM]**.

Joint Permit Application

- On June 17, 2011, Detroit Edison submitted a Joint Permit Application (JPA) for actions affecting wetlands on the Fermi site. Detroit Edison provided a courtesy copy to NRC. MDEQ issued an Application Correction and subsequent Clarification Request regarding the submittal. Detroit Edison met with MDEQ on August 9, 2011. An updated JPA information package, including the conceptual wetlands mitigation plan was submitted to MDEQ on August 26, 2011. Although most changes were organizational, some technical changes were made to the JPA. Detroit Edison will forward a courtesy copy of the revised JPA to the NRC for review **[ACTION ITEM]**.
