Prior to release of your current facilities at 6 Commons Street, Rutland, Vermont and 1 Commons Street, Rutland, Vermont, for unrestricted use, you must submit an Amendment request removing your current facilities from your license. Include in the request, the results of surveys demonstrating that the levels of residual activity in the facility are acceptable. When you submit the Amendment request, please refer to the Control Number at the top of this letter.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
