Subject: Clarification and Information

Dear Mr. Torres:

This letter is in response to your letter dated August 12, 2011. We are hereby providing information, clarification and our commitment as follows:

Item #1: We are not anticipating any additional gauges at this time.

Item #2: We will implement and maintain the "Operating, Emergency, and Security Procedures" described in the errata sheet to Appendix H of NUREG-1556, Volume 1, Revision 1, and provide copies of these procedures to all gauge users and at each job site.

Item #3: We will perform leak test for portable gauges Troxler 3400 Series at a 12 month frequency through Forney, Troxler or a reputable testing company.

Item #4: Indo American Engineering will offer for transportation non-bulk packages that will be marked with the proper shipping name and identification number. The non-bulk packages (Type A shipping containers will have labels identifying the material as UN3332, Radioactive Material, Type A package, Special Form 7, RQ. In addition, the inventory log, bill of lading and any other regulatory required documentation will indicate UN3332, Radioactive Materials; Type A package, Special Form 7, RQ.
