SUBJECT: REQUEST FOR ADDITIONAL INFORMATION

The NRC has completed the technical review of the renewal application dated July 28, 2011, and additional information is needed to complete the renewal process. Please provide the following information or commitments for NRC review within 20 business days from the date of receipt of this letter. Make reference to mail control number 575716 when providing your response.

1. The most current amendment to NRC License No. 11-27540-01 issued to Kleinfelder, Inc., (amendment number 12 dated November 30, 2010) shows 2812 Hunter Drive, Blue Springs, Missouri, as a location where licensed material is stored or used. The renewal application did not list this location. Request that this location be added as part of the renewal application or request that the location be released for unrestricted use and submit copies of leak test results for all the gauges stored at this location.
2. Revised 10 CFR 30.34 requires that "each portable gauge licensee shall use a minimum of two independent physical controls that form tangible barriers to secure portable gauges from unauthorized removal, whenever portable gauges are not under the control and constant surveillance of the licensee" (i.e., when not in use). Guidance on these security procedures is provided in the errata sheet to Appendix H of NUREG-1556, Volume 1, revision 1, which can be found at: <http://www.nrc.gov/reading-rm/doc-collections/nuregs/staff/sr1556/v1/r1/apph-errata.pdf>.

Commit to the following language: "We will implement and maintain the "Operating, Emergency and Security Procedures" described in the errata sheet to Appendix H of NUREG-1556, Volume 1, Revision 1, and will provide copies of these procedures to all gauge users and at each job site."

3. Incorporate in Kleinfelder's Operating and Emergency procedures the NRC's Headquarters Operation Center telephone number to report events that require regulatory notification. The telephone number is 301-816-5100 and collect calls are accepted.
