
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to provide incremental funding in the amount of \$394,000.00 thereby increasing the total obligations from \$466,000.00 to \$860,000.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$860,000.00 of which \$817,860.00 represents the estimated reimbursable costs, and the amount of \$42,140.00 represents the fixed fee."

All other terms and conditions remain the same.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
