Large Scale Simulation of an Extreme Earthquake

On August 31, 2011, as a result of a non-competitive solicitation, a cost reimbursement, no fee contract (NRC-HQ-11-C-04-0067) was awarded to the University of Nevada, at Reno, to perform a Large Scale Simulation of a Base-Isolated Structure of Extreme Earthquakes. The period of performance is August 31, 2011, through August 20, 2012, with no option periods. The total estimated value is \$280,463.00.

New International Commission on Radiological Protection; Recommendations on the Annual Dose Limit to the Lens of the Eye; Request for Public Comment, 10 CFR Chapter I (NRC-2009-0279)

On August 30, 2011, the NRC published a proposed rule in the *Federal Register* (76 FR 53847) seeking public comment on recommendations recently released by the International Commission on Radiological Protection for the limitation of annual radiation dose to the lens of the eye. Stakeholders and the public are encouraged to submit comments on the issues discussed in this notice by October 31, 2011.

Differing Professional Opinion (DPO) Decision on Enforcement Policy Issues

On June 28, 2011, the Director, Office of Enforcement, issued a decision on a Differing Professional Opinion (DPO) involving how enforcement decisions were made related to a materials licensee. On January 24, 2011, an NRC employee submitted a DPO that focused on a major enforcement action being taken without prior communication between agency management and the licensee, and indicating that NRC escalated enforcement actions should refrain from revoking the general license granting ownership (vice possession and use) unless a nexus to safety and security can be established. The DPO further noted that the agency could have met its safety and security goals with fewer unintended consequences if an Order had been drafted more carefully. On May 11, 2011, an Ad Hoc Review Panel provided the results of its independent review to the Director, OE. The Panel concluded that: 1) the agency's decision to issue orders without first offering a pre-decisional enforcement conference or issuing a Demand for Information satisfied the guidelines of the Enforcement Policy, and 2) the decision to ban owning licensed material was reviewed, deliberated, and agreed upon in accordance with normal enforcement processes. The decision was tied to staff concerns about the potential safety consequences of allowing the control over licensed material. The Panel recommended that guidance to staff (and possibly licensees) regarding the scope and meaning of the phrase "licensed activities" is needed. Further the Panel recommended that guidance to staff on how to draft orders in a manner that avoids unintended consequences may be warranted. Based on a review of the Panel's report and additional comments from the DPO submitter, the Director, OE agreed with the Panel's conclusions and recommendations. Also, the Director, OE agreed with the DPO submitter that it is highly unusual to take a major enforcement action without providing the licensee the opportunity to respond to the findings; however, in this case the action was deemed necessary to protect public health and safety. Dispute Resolution Skills Training

On August 30, 2011, staff from the Information and Records Services Division, attended dispute resolution skills training sponsored by the Office of Government Information Services (OGIS). Freedom of Information Act (FOIA) Public Liaisons (FPLs) play a crucial role in the FOIA process, resolving disputes and serving as the point of contact for requesters. In support of this role, OGIS offers this training program to provide FPLs with dispute resolution tools that can be applied to FOIA disputes at their agencies. Key presentations included: Alternative Dispute Resolution Techniques, OGIS' Role and Process, Key Elements of a Good Communicator, Effective Management of the FOIA Process, Appeals Process, and Analyzing Problem Behaviors.

National Archives and Records Administration (NARA) Guidance Meeting

On August 30, 2011, staff from the Information and Records Services Division, Office of Information Services, met with the NARA staff regarding the NRC's use of NARA's records storage services. The purpose of the meeting was to discuss funding for the Interagency Agreement between the NRC and NARA, as well as additional services available to the NRC over the next five years. A key topic of the meeting was to plan for the Fiscal Year 2012 transfer of NRC's Regional records to NARA facilities that are in proximity to NRC regional offices.

Fuel Cycle Safety and Safeguards Response Training has been completed for FY 2011. With the support of the Office of Nuclear Security and Incident Response, all three teams (Red, White, and Blue) participated in different Table Top exercises in the Emergency Operations Center during August. All team members have or will have completed and received credit for the on-line training portion of their qualifications prior to the end of September. Thus, 100% of the team members will be qualified and have met the requirement for participation in the Table Top exercises at least once every two years. In the near future, we will be gathering insight from all participants to see how we can improve our response capability and readiness in the future.

Electric Power Research Institute (EPRI) Joint Utility Task Group (JUTG) Procurement Forum Highlight

On August 23-25, 2011, staff participated in the EPRI JUTG Procurement Forum in Minneapolis, Minnesota. The forum was attended by nuclear vendors, Nuclear Procurement Issues Committee member utilities, EPRI, Nuclear Energy Institute, and American Society of Mechanical Engineers NQA-1 Standard representatives. During the meeting, the staff discussed the proposed rulemaking related to 10 CFR Part 21. This led to numerous discussions and suggestions for the rulemaking. Staff members also participated in an open forum session entitled "Ask the Regulator."

Safety Evaluation Report (SER) with Open Items for Columbia Generating Station License Renewal Application

On August 30, 2011, the staff issued the SER with Open Items for the Columbia Generating Station license renewal application, which was received from Energy Northwest by letter dated January 19, 2010. The SER has six open items: operating experience review prior to entering the period of extended operation; aging management of high voltage porcelain insulators; environmentally-adjusted fatigue values other than those identified in NUREG/CR-6260; stress relaxation of the core plate hold-down bolts; time limited aging analysis of the polar crane; and the technical basis of the initial upper shelf energy for the N12 nozzles. The staff is scheduled to meet with the Advisory Committee on Reactor Safeguards Subcommittee on October 19, 2011, to discuss the SER with Open Items.

Supplemental Safety Evaluation Report (SSER) for Indian Point License Renewal Application

On August 30, 2011, the staff issued an SSER for the Indian Point Nuclear Generating, Unit Nos. 2 and 3, license renewal application. The SSER documents the staff's review of additional information provided by the applicant since the staff's issuance of the SER in November 2009. This information includes annual updates required by 10 CFR 54.21(b) and updated information and commitments in response to recent industry operating experience. The staff concluded that the additional information provided did not alter the conclusions stated in the SER issued in November 2009.

The NRC Generic Issues Program has begun to report the status of proposed issues that are in process or were determined not to meet the generic issue scoping criteria in order to enhance the program's transparency and accountability.
