

SUBJECT: Second Review

Introduction

The application for a NonSignificant Revision to modify or eliminate certain Mine Unit 7 perimeter monitor wells was received August 10, 2011, under cover of Jon Winter's letter of August 9, 2011. Additional information was received August 22, 2011, under cover of Jon Winter's letter dated August 18, 2011.

Comments from Don Fischer, Mark Taylor and me were sent to Mr. Winter under cover of my letter of August 23, 2011. A response package was received August 30, 2011, under cover of Mr. Winter's letter dated August 29, 2011.

Discussion

The object of the NSR was to recomplete a number of perimeter monitor wells so that their completion intervals were in the same sands as the nearby ore sands. Also part of the NSR was the proposal to eliminate four perimeter monitor wells on the western side where they formed a bulge that was too far from the wellfield

Review

Earlier comments which did not require a response have been eliminated.

1. Indexes of Changes

The Index of Changes received on August 30, 2011, accurately lists the items to be removed and inserted into the document.

2. Continuity

No continuity problems were detected.

3. Map Figure A-1, Mine Units 6 and 7 Groundwater Quality and Well Completions

A revised map was provided depicting 6MW19 in red which would show it is a Mine Unit 7
