In its Order dated January 8, 2009, the Atomic Safety and Licensing Board ("Board") directed the NRC staff ("Staff"), commencing on January 15, 2009, to tender each month "a short report advising as to whether the estimated dates for issuance of the final [Safety Evaluation Report ('SER')] (predicted for summer/fall of 2009) and final [environmental review document] (predicted for December of 2009) have changed or become more definitive." The Staff continues to expect to issue the SER by December 2011. Likewise, the Staff continues to expect at this time to issue the final environmental review document by December 2011.

In keeping with the Board's mandate, the Staff will tender its next monthly status report by October 14, 2011.
