SUBJECT: SUMMARY OF NUCLEAR REGULATORY COMMISSION (NRC)
PUBLIC OUTREACH MEETING ON SEPTEMBER 8, 2011 in
Erwin, TN (DOCKET 70-143)

SUMMARY: This memo refers to the public outreach meeting at the Unicoi High School Auditorium in Erwin, TN on September 8, 2011. The outreach meeting was held in two parts. The first portion of the meeting was conducted by the National Academy of Sciences (NAS), who presented information regarding the national cancer study they are conducting around nuclear facilities, such as Nuclear Fuel Services, under an NRC contract. The formal NAS presentation was then followed by a brief question and answer session. The NAS slides can be found under accession number ML112551204.

The NRC then began the second portion of the meeting with presentations in two regulatory areas. The first NRC presentation presented information regarding the origin of the public dose limits from Part 20 of Title 10 of the *Code of Federal Regulations*. The slides used for this presentation can be found under accession number ML11255A201. The final NRC presentation presented the NRC's enforcement policy and process. The slides used for that presentation can be found under accession number ML11255A203. After both NRC presentations a brief question and answer session was held. After all the presentations, the auditorium was opened for general questions and answers regarding all the presentations.

The meeting accomplished the goal of communicating information requested at previous public meetings related to NRC activities (as it pertained to Nuclear Fuel Services) in a public setting that offers the opportunity to ask questions directly of the subject experts.
