AMENDED: NRC ADVISORY COMMITTEE ON MEDICAL USES OF ISOTOPES TO MEET SEPT. 22-23, IN ROCKVILLE, MD.

The U.S. Nuclear Regulatory Commission's Advisory Committee on Medical Uses of Isotopes (ACMUI) will meet Sept. 22-23 in Rockville, Md.

Meeting topics include the status of a Commission paper on data collections regarding patient release; perspectives from the NRC staff and the U.S. Food and Drug Administration on the strontium breakthrough with rubidium-82 generators; medical-related events; outcomes from the NRC medical-related rulemaking workshops; possible changes to the permanent implant brachytherapy subcommittee report; and the status of the medical use of byproduct material (10 CFR Part 35) rulemaking.

The ACMUI advises the NRC on policy and technical issues related to the regulation of medical uses of certain radioactive materials.

The public portion of the meeting will be on Thursday, Sept. 22, from 1:30 to 5 p.m. and Friday, Sept. 23, from 8 a.m. to 4 p.m. An [ACMUI detailed agenda](#) is available on the NRC website.

The meeting will be held on September 22 at NRC Headquarters One White Flint North Building, room O1-F16/O1-G16 and on September 23 at NRC Headquarters Two White Flint North Building, room T2-B3, 11545 Rockville Pike, Rockville, Md.
