Gentlemen:

Your May 13, 1974 response to our April 4, 1974 request for additional information related to the Prompt Relief Trip (PRT) system is unacceptable because contrary to earlier understandings with General Electric representatives, you plan no modifications to the system you proposed by letter dated January 23, 1974, to:

- a. minimize the possibility of inadvertent actuation of more than one safety relief valve, and
- b. provide testability of the PRT system in accordance with Regulatory Guide 1.22.

Until suitable changes are submitted for our review, we cannot approve completion of the PRT installation in Monticello.
