NRC Request for Information on
Management and Technical Resources

Your letter dated June 29, 1979 requested information by July 30, 1979 on management and technical resources available to licensees for response to nuclear plant emergencies. A subsequent letter from W P Haass, Chief, Quality Assurance Branch, requested that we submit a total of 50 copies of the requested information based upon NSP operating three units.

Since our response involves securing resume's for over 150 individuals, preparing other supporting information, and printing the large number of copies requested, we were unable to meet the suggested July 30, 1979 date. We advised Mr Haass by telephone several days ago that our submittal would be delayed. We expect to have the information in the mail on or before August 13, 1979. Mr Haass asked us to confirm this in writing to you.
