12/12/11 (13:05) I spoke with Mr. Fjord about the timetable of BTU Solution's acquisition of the assets of AES Thames. BTU intends to complete the purchase of the remaining assets of AES Thames on January 1, 2012. The individuals that he has been in contact with are Mark Boucher, Site Manager and Steven Hawkins. The contact information for Mr. Hawkins was 860-848-9223 X123 or steve.hawkins@aes.com. I provided information to Mr. Fjord concerning what to do in case it was suspected that the gauges would still onsite on January 1, 2012, which could be found in NUREG-1556, Vol. 15. While we were completing our conversation, Mr. Fjord received an e-mail from Mr. Hawkins indicating that AES Thames had received a quote for the disposal of the gauges.

(15:00) I returned Mr. Hawkins call which was received by my voice-mail messaging system about 12:45. He indicated that the gauges would be taken down by the manufacturer's representative later this week. He understood that the gauges needed to be wipe tested prior to transfer and hoped the local representative would have a quick turnaround time. I explained that in order for the NRC to free release the facility we would need a completed copy of NRC Form 314, copies of the leak test reports, and, preferably, a letter from the manufacturer indicating that they had received the sources. Requesting that the action be completed by a certain date as an "expedite" would also help matters. I informed Mr. Hawkins that responsibility for his license belonged with another branch and that the two person's responsible would be Craig Gordon and Shawn Seeley. I would still be available to answer questions if there should be a need.
