In August, 2003; April, 2004 and January 2007 the Corps of Engineers held public information sessions to present and discuss the Remedial Investigation, Feasibility Study and Proposed Plan for the Parks Township Shallow Land Disposal Area (SLDA). These activities and subsequent work at the site were steps in the site investigation and cleanup process outlined in the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA). The Remedial Investigation, Feasibility Study, Proposed Plan, and the Record of Decision (ROD) for the SLDA site have now been completed. The Pittsburgh District Corps of Engineers is now finalizing the detailed design for the remediation effort.

The purpose of the public information session is to discuss the upcoming clean-up effort for the SLDA and solicit input from the public. Representatives of the Project Delivery Team will be available to answer your questions and explain how the SLDA remediation process will be implemented in the field.

The Corps of Engineers team welcomes and encourages your questions and comments concerning the detailed design for the remediation of the Parks Township SLDA.

Copies of the Remedial Investigation Report, Feasibility Study, Proposed Plan and ROD are available at the Apollo Memorial Library, 219 North Pennsylvania Ave, Apollo, Pa 15613.

Directions to the Parks Township Volunteer Fire Department No. 1 Social Hall (located next to the Fire Station)

From Leechburg: Take PA Route 66 south. After passing Lee's Lanes (bowling alley) continue about ¼ mile to Penn Avenue on the left. Turn left on to Penn Avenue. At the second stop sign, turn left and proceed up the hill. After about ½ mile, look for Dalmation Drive and the Parks Township Volunteer Fire Department sign on the right.

From Vandergrift: At the Alternate PA Route 66 bridge over the Kiskiminetas River, turn left in North Vandergrift onto PA Route 66. After exiting North Vandergrift make the first right onto Penn Avenue. Once on Penn Avenue make a right at the first intersection onto Pleasant View Drive and proceed up the hill. After about ½ mile, look for Dalmation Drive and the Parks Township Volunteer Fire Department sign on the right.
