We have essentially completed our evaluation of the fire protection program for this plant. The results of our review are described in the enclosed Draft Safety Evaluation Report.

We find the licensee's fire protection program acceptable subject to the implementation of the proposed modifications and the resolutions of open items identified in Section 3.0 of the report. The open items described in Sections 3.2.1, 3.2.2, 3.2.3, 3.2.4, 3.2.5, 3.2.6, 3.2.7 and 3.2.8(1) have been discussed formally or informally with the licensee. The open items described in Section 3.2.8(2), 3.2.9, 3.2.10 and 3.2.11 are new requirements which have not been discussed with the licensee.

Our consultant's report is scheduled to be completed by May 1, 1979. Upon receipt of the consultant's report, we will provide to you Appendix B to the DSER which will identify those consultant's recommendations which were not adopted by the staff and our responses to the consultant's report. The SER should not be issued until Appendix B is completed.
