On October 25 - 26, 2011, and continued in-office until January 12, 2012, Randolph Ragland and Craig Gordon of this office conducted a safety inspection at the Sault Sainte Marie, Michigan, Port of Entry, of activities authorized by the above listed NRC license. The inspection included a routine review of your licensed program. The findings of the inspection were discussed with you, Steven Tilden, Radiation Safety Officer, and Chief Douglas Price, Assistant Port Director, at the conclusion of the inspection on January 12, 2012. The enclosed report presents the results of this inspection.

Within the scope of this inspection, no violations of NRC requirements were identified.
