Dear Mr. Kimmel:

On July 11, 2011, the U. S. Nuclear Regulatory Commission (NRC) issued Cleanlites Recycling (CR) a letter transmitting a Notice of Violation. The letter stated, in part, that the NRC was in the process of obtaining information regarding your compliance with Title 10 of the Code of Federal Regulations (CFR), Part 110 as it pertained to CR's exportation of hydrogen-3 exit signs to Canada and that we would inform you of our findings in a separate correspondence upon completion of our review of this matter.

During a teleconference on January 17, 2012, Robert Gattone of my staff informed you that we had completed our review and determined that no violation of 10 CFR 110 resulted from CR's exportation of hydrogen-3 exit signs to Canada. Specifically, CR did not violate the provisions of the general license described in 10 CFR 110.23 because the radioactivity of each shipment (three in all) of tritium exit signs pursuant to disposal was within the allowable limits for export to Canada under the general license. We have no further questions regarding this matter; therefore, we consider the matter closed.
