Based on the information gathered at the time of the inspection, we understand that you do not have plans to resume this business and are currently working with the bank regarding the property. In addition, you have hired a consultant to properly disposition the 28 radioactive sources in your possession; leak test the applicable sources prior to transfer; conduct a final status survey of the Hot Lab, PET-CT camera room, and Stress Laboratory; and terminate your NRC license.
