SUBJECT: U.S. EPR DESIGN CERTIFICATION APPLICATION – SAFETY
EVALUATION REPORT WITH OPEN ITEMS FOR PORTIONS
OF CHAPTER 9, “AUXILIARY SYSTEMS”

By letter dated December 11, 2007, AREVA NP Inc., (AREVA) submitted an application to the U.S. Nuclear Regulatory Commission (NRC) for a standard design certification (DC) application for the U.S. EPR.

Based on our review of the application, the staff is providing the Advisory Committee on Reactor Safeguards (ACRS) its Safety Evaluation (SE) for with Open Items (OIs) for portions of Chapter 9, Group II, “Auxiliary Systems,” (Agencywide Documents Access and Management System (ADAMS) Accession No. ML 110970639), which includes Section 9.1. Unless otherwise stated in the SE with OIs, the staff’s review was based on Revision 2 of the application and AREVA’s responses to Requests for Additional Information (RAIs). The SE with OIs is being provided to support a meeting of the subcommittee of the ACRS scheduled to be held on February 21-23, 2012. The ACRS full committee meeting will be held at a later date.

In accordance with Michael R. Johnson’s memorandum to the ACRS dated March 17, 2010, the staff has reviewed our submitted information against the categories for which the ACRS requested be used to highlight information for review by the Committee. The staff’s assessment of this chapter is that there are no items that meet the categories for discussion with the Committee.
