Dear Administrative Judges:

Pursuant to 10 C.F.R. §§ 2.1203 and 2.336 and as modified by the Atomic Safety and Licensing Board's ("Board") Memorandum and Order dated June 15, 2011 ("Order"), the staff of the Nuclear Regulatory Commission ("Staff") is providing an index identifying documents subject to disclosure under the Board's Order. On or about February 7, 2012, materials in the hearing file may be accessed through the Agencywide Documents Access and Management System ("ADAMS") and through the Electronic Hearing Docket ("EHD"). The index contains the ADAMS accession number, document date, and the document title.

Pursuant to 10 C.F.R. § 2.336(c), attached is the Affidavit of Samuel Cuadrado De Jesus, certifying that all relevant materials required by this section have been disclosed, and that the disclosures are accurate and complete as to documents identified by January 25, 2012.

The NRC Staff notes that it has made a good faith effort to identify and characterize all documents meeting the criteria of 10 C.F.R. § 2.336(b) and 10 C.F.R. § 2.1203 in this proceeding. In identifying these documents, the Staff does not concede their relevance to the license renewal issues to be decided in this proceeding.

The NRC Staff notes that it is currently expecting to publish the Safety Evaluation Report ("SER") with open items and SER in March 2012 and October 2012, respectively. As noted in our January 25, 2012 letter to the Board, the Staff is unable to project dates for the publication

of the Draft Supplemental Environmental Impact Statement (“DSEIS”) and the Final SEIS at this time.
