On November 29 - December 2, 2011, Randolph Ragland of this office conducted a safety and security inspection at your facility located at the Doral Bank Plaza, 33 Resolution Street, 4th Floor, Suite 401, San Juan, Puerto Rico, of activities authorized by the above listed NRC license. The inspection was continued in-office and included a review of additional information provided in a telephone conversation on January 24, 2012, between Victor Morales, Radiation Safety Officer, of your organization and Randolph Ragland of this office. The findings of the inspection were discussed with you and Victor Morales, by telephone, at the conclusion of the inspection on January 24, 2012.

Based on the results of this inspection the NRC identified security-related violation(s). Because the NRC identified the violation(s) and the violation(s) are categorized at Severity Level IV in accordance with the NRC Enforcement Policy, the violation(s) are being cited in the enclosed Notice of Violation (Notice). The Enforcement Policy is included on NRC's website at www.nrc.gov; select **About NRC; How We Regulate; Enforcement**; then **Enforcement Policy**.

The NRC has concluded that information regarding the reason for the violation(s), the corrective actions taken and planned, and the date when full compliance was achieved is already adequately addressed on the docket as summarized in Enclosure 2. Therefore, you are not required to respond to this letter unless the description therein does not accurately reflect your corrective actions or your position. In that case, or if you choose to provide additional information, you should follow the instructions specified in the enclosed Notice.
