In Reference 1, South Carolina Electric & Gas Company (SCE&G) submitted an updated application to the U.S. Nuclear Regulatory Commission (NRC) requesting combined licenses (COLs) for two AP1000 advanced passive pressurized water reactors designated V. C. Summer Nuclear Station (VCSNS) Units 2 and 3 to be located at the existing VCSNS site in Fairfield County, South Carolina which included an update to COLA Part 7, Departures and Exemptions.

In Reference 2, SCE&G submitted another update to the COLA which incorporated by reference the AP1000 Design Control Document (DCD) Revision 19. No update to COLA Part 7 was included in that submittal as no changes to any departures were identified.

In accordance with the requirements of paragraphs X.B.1 and X.B.3.b of Appendix D to 10 CFR Part 52, the purpose of this letter is to update the VCSNS Units 2 and 3 Departures Report. No additions, deletions, or changes to the VCSNS Units 2 and 3 Departures Report have been identified during this most recent six-month reporting period, and therefore the updated COLA Part 7 submitted in Reference 1 is still applicable.
