The purpose of this modification is to add FY12 incremental funding in the amount of \$10,000.00, which increases the obligated amount on this contract from \$210,051.84 to \$220,051.84.

Accordingly, the following changes are made:

1) Article A.3 **CONSIDERATION AND OBLIGATION—TIME AND MATERIALS**, paragraph (b) is revised as follows:

(b) This obligated amount may be unilaterally increased from time to time by the Contracting Officer by handwritten modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done at the Contractor's sole risk.
