Double check my math please....your license condition says **at least 14 days notice BEFORE activities**, right?

Here is license condition 15.A from your license:

At least 14 days before initiation activities at a temporary job site, the licensee shall notify, in writing, the U.S. Nuclear Regulatory Commission, Region I, ATTN: Director, Division of Nuclear Materials Safety, 475 Allendale Road, King Prussia, Pennsylvania 19406. The notification shall include the following information:

- (i) Estimated type, quantity, and physical/chemical form(s) of material;
- (ii) Specification of the site location;
- (iii) Description of project activities including waste management and disposition;
- (iv) Estimated project start date and duration; and

(v) The name and title of a point of contact for the job, including information on how to contact the individual.

Your letter is dated 2/2/2012, right?
If I add 14 days, I get 2/16/12, right?
Your letter says you will start activities 2/15/12, right?

So how are you complying?

You can't start on 2/15/2012.
At the earliest you may start at 2/16/2012.

We really need these notifications on time.
