
The purpose of this contract modification is to increase the obligated amount by \$272,000 from \$3,698,173.58 to \$3,970,173.58. Accordingly, Section B.3 CONSIDERATION AND OBLIGATION- COST PLUS FIXED FEE - ALTERNATE I (JUN 1991), paragraph (g) is revised to the following:

"(g) The amount currently obligated by the Government with respect to this contract is \$3,970,173.58, of which the sum of \$3,673,822.58 represents the estimated reimbursable costs, and of which \$296,351.00 represents the fixed fee."

All other terms and conditions remain the same.
