The purpose of this modification is to provide \$5,000.00 of incremental funding, thereby increasing the total obligated amount from \$303,000.00 to \$308,000.00.

Accordingly the following revisions are hereby made:

A.2 CONSIDERATION AND OBLIGATION—TIME AND MATERIALS, is revised to read as follows:

(a) The total estimated exercised ceiling amount of this contract is **\$482,817.60** the total estimated ceiling amount of this contract including options is **\$814,675.60**.

(b) The amount presently obligated with respect to this contract is **\$308,000.00**. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.
