The purpose of this modification is to:

1. Add incremental funds in the amount of \$225,000.00, thereby increasing the total obligated amount from \$150,000.00 to \$350,000.00.

Accordingly, the contract is modified as follows:

1. Paragraph (b) under Section A.3 CONSIDERATION AND OBLIGATION—LABOR HOURS is revised to read as follows:

" (b) The amount presently obligated with respect to this contract is \$350,000.00. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in the paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above done so at the Contractor's sole risk."
