2) Physical Description

This shipment will consist of 4 x 30B "Heeled" Cylinders in sealed overpacks on 2 x 20' flatracks containing 27 kg of Uranium. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, FISSILE (HEELS) and 4 x 30B Empty, Cleaned and Washed Cylinders in sealed protective overpacks RADIOACTIVE MATERIAL, EXCEPTED PACKAGE, EMPTY PACKAGES.

3) Transportation and Route Schedule

The surface transportation from Richland, WA to Halifax, NS will be the responsibility of RSB LOGISTIC SERVICES INC. The ocean transportation from Halifax, NS to Hamburg, Germany will be the responsibility of Atlantic Container Line. Export from the United States will occur at Sweetgrass, MT on or about December 3, 2011.
