2) Physical Description

This shipment consists of 16 x 48Y Cylinders loaded on 16 x 20' flatracks. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U is 131,600 kgs. The net weight of U-235 is 944 kgs.
