SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE  
FOR GRAND GULF NUCLEAR STATION, UNIT 1 (TAC NO. ME2531)

Dear Sir or Madam:

By letter dated December 1, 2011 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML113360294), you submitted an affidavit dated November 29, 2011, executed by Mr. James F. Harrison, GE Hitachi Nuclear Energy Americas LLC (GEH), to the U.S. Nuclear Regulatory Commission requesting that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

Attachment, GNRO-2011/00[110], "GEH Report NEDC-33692P, Rev. 1, Grand Gulf Nuclear Station Power Range Neutron Monitor V&V Test Summary Report (GEH Proprietary Version)"

Due to the extent of proprietary information contained in this document, GEH was not required to submit a nonproprietary version.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by GEH's competitors without license from GEH constitutes a competitive economic advantage over other companies.
- b. Information that, if used by a competitor, would reduce their expenditure of resources or improve their competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.



We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.

If the basis for withholding this information from public inspection should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC. You also should understand that the NRC may have cause to review this determination in the future, for example, if the scope of a Freedom of Information Act request includes your information. In all review situations, if the NRC makes a determination adverse to the above, you will be notified in advance of any public disclosure.
