Enclosed for your records is the signed Memorandum of Agreement (MOA) between the U.S. Nuclear Regulatory Commission, the Michigan State Historic Preservation Officer (SHPO), Detroit Edison Company (DTE), and Monroe County Community College (MCCC) regarding the demolition of the Enrico Fermi Atomic Power Plant, Unit 1 (Fermi 1) facility located in Monroe County, Michigan.

Please note that this signed MOA differs from the version enclosed in the letter to you from Mr. Brent Clayton dated October 13, 2011, as follows:

1. In Stipulation II, DTE will now consult with MCCC (vs. the American Nuclear Society) and other interested parties in establishing the Fermi 1 exhibit, which will be established within 2 years of the execution of the MOA.
2. The second paragraph in Stipulation III is new.
3. The first sentence in Stipulation V is new.
4. MCCC is now an invited signatory.

These changes were made at the request of Brian Grennell of the SHPO's Cultural Resource Management & Planning Section after the MOA was sent to seven potentially interested parties. None of the potentially interested parties had comments or suggested changes to the MOA.
